ELIZABETHTOWN BOROUGH COUNCIL REGULAR MEETING March 16, 2017 Minutes

Elizabethtown Borough Council held a public hearing on Thursday, March 16, 2017 at 7:00 p.m. at the Borough Office relative to an application from Babbo's, Inc. for inter-municipal transfer of a retail liquor license from 2000 West Main Street, Mount Joy, to 655 North Market Street, Elizabethtown. Council President J. Marc Hershey called the hearing to order and turned the floor over to Community Development Director Rodney Horton who introduced the application.

Jack Smith, Esq., presented the request on behalf of the applicant, Salvatore Caretti, and introduced Massimo Caretti who was present representing his father. Various exhibits were added to the record in support of the request, and it was noted that the proposed location is the same space from which the business operated before selling to Pizza Town. Caretti noted the family is interested in simplifying operations at the North Market Street location. The menu will be smaller, no hard liquor will be offered, and no bar is planned as part of the restaurant. Caretti stated he will be managing the operation as he currently does in Mount Joy, and is well aware of Liquor Control Board (LCB) regulations having been in the business for more than 30 years.

Council questions centered on the amount of seating in the facility, parking accommodations, timeline, and final approval by the LCB. **Carol Witmer, 129 Maple Street,** expressed her feeling that it will be wonderful to have Babbo's move to North Mount Joy Street.

Being no further comment, Hershey closed the hearing at 7:22 p.m. and immediately called the regular meeting to order. Present were Councilmembers Phil Clark, J. Neil Ketchum, Jr., Jeff McCloud, Tom Shaud, Dr. C. Dale Treese and J. Marc Hershey. Also present were Borough Manager Roni Ryan, Assistant Borough Manager Cindy Foster, Public Works Director Wayne Devan, Community Development Director Rodney Horton, Police Lieutenant John Emrick, and Mayor Chuck Mummert.
