Fixing and determining the corporate boundary of the said Borough; regulating the assessments in the annexed territory.
3/15/1927	3/15/1927	Extending the Borough limits of the Borough of Elizabethtown, Pennsylvania, authorizing the annexation of a part of Mount Joy Township, approximately 20 acres in area, belonging to Frank W. Groff, W.A. Withers, F.B. Aldinger and S.F. Ulrich.
3/18/1941	3/18/1941	Annexing a portion of Mount Joy Township to the Borough of Elizabethtown, Lancaster County, Pennsylvania. This refers to 21 acres southwest of the Borough line.
9/18/1945	9/18/1945	Annexing certain land in Mount Joy Township of Elizabethtown. This refers to 25.066 acres, the property of Claude E. Disney, Kathryn D.R. Disney, Kenneth E. Baker and Sara D. Baker.
7/20/1948	7/20/1948	Annexing to the Borough of Elizabethtown, Lancaster County, Pennsylvania, a part of Mount Joy Township, Lancaster County, Pennsylvania, contiguous to said Borough of Elizabethtown. This refers to 29.77 acres belonging to Loy Trostle, Joseph Helm, Mariam Dickson, Robert and Mary Shank, Paul and Jean Beard, Lee and Hilda Livingston, William and Jean Herdle, E. Rudolph Harzer, George Wells, Richard Myers, P.W. Heisey, W.D. Groff and Mark Mavretic.
9/24/1953	9/24/1953	Annexing a portion of Mount Joy Township to the Borough of Elizabethtown. This refers to 13.1 acres adjoining the eastern boundary line of the Borough, which becomes part of the Second Ward upon annexation.
3/21/1955	3/21/1955	Annexing a portion of Mount Joy Township to the Borough of Elizabethtown. This refers to 9.6 acres adjoining the eastern boundary line of the Borough, which becomes part of the Second Ward upon annexation.

This refers to 24.79 acres, which were to become part of the First Ward upon annexation.
1/21/1958	1/21/1958	Approving a petition for annexing to the Borough of Elizabethtown a section of Mount Joy Township, Lancaster County, Pennsylvania, adjacent to and east of said Borough of Elizabethtown. This refers to a tract of approximately 29.37 acres along and south of East High Street.
346	8/19/1958	Approving the petition for annexing to the Borough of Elizabethtown a section of Mount Joy Township, Lancaster County, Pennsylvania, adjacent to and east of said Borough of Elizabethtown. This relates to 24.16 acres, to become part of the Second Ward.
383	5/26/1959	Approving the petition for annexing to the Borough of Elizabethtown a section of Mount Joy Township, Lancaster County, Pennsylvania, adjacent to and east of said Borough of Elizabethtown. This contains 16.62 acres of land.
386	8/15/1959	Approving the petition for annexing to the Borough of Elizabethtown a section of Mount Joy Township, Lancaster County, Pennsylvania, adjacent to and east of said Borough of Elizabethtown, containing 16.62 and 25.9 acres of lands.
