ORDINANCE NO. 1015

AN ORDINANCE OF THE BOROUGH OF ELIZABETHTOWN, LANCASTER COUNTY, PENNSYLVANIA, AMENDING PORTIONS OF CHAPTER 15, MOTOR VEHICLES AND TRAFFIC OF THE CODE OF ORDINANCES TO MODIFY ON-STREET PARKING REGULATIONS.

<u>Section 1.</u> The Elizabethtown Borough Code of Ordinances, Chapter 15, Motor Vehicles and Traffic, Part 4, General Parking Regulations, Section 403, Parking Prohibited at All Times in Certain Locations, shall be amended to delete the following:

Street	Side	Between
W. Washington Street	South	S. Peach Alley and S. Poplar Street
W. Willow Street	Both	N. Market Street to a point 134 feet westward of N. Market Street

<u>Section 2.</u> The Elizabethtown Borough Code of Ordinances, Chapter 15, Motor Vehicles and Traffic, Part 4, General Parking Regulations, Section 403, Parking Prohibited at All Times in Certain Locations, shall be amended to add the following:

Street	Side	Between
W. Washington Street	North	A point 169 feet westward of S. Market Street and a point 246 feet westward of S. Market Street
W. Washington Street	South	S. Poplar Street and a point 260 feet eastward
W. Willow Street	South	N. Market Street and a point 45 feet westward of N. Market Street
W. Willow Street	Both	A point 20 feet westward from Peach Alley and a point 10 feet eastward from Peach Alley

<u>Section 3.</u> The Elizabethtown Borough Code of Ordinances, Chapter 15, Motor Vehicles and Traffic, Part 4, General Parking Regulations, Section 406, Parking Time Limited in Certain Locations Certain Days and Hours, shall be amended to delete the following:

Street	Side	Between	Days	Hours	Parking Time Limit
W. Washington Street	North	S. Market Street and S. Peach Alley	Sun	7 a.m. to 1 p.m.	Church Purpose Only

<u>Section 4.</u> If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or

parts of this Ordinance. It is hereby declared as the intent of the Borough that this
Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence,
clause, section, or part thereof not been included herein.

<u>Section 5.</u> All other sections, parts and provisions of the Borough of Elizabethtown Code of Ordinances shall remain in full force and effect as previously enacted and amended.

<u>Section 6.</u> This Ordinance shall become effective immediately upon its enactment by the Council of Elizabethtown Borough, County of Lancaster, Commonwealth of Pennsylvania.
