BOROUGH OF ELIZABETHTOWN LANCASTER COUNTY, PENNSYLVANIA

A RESOLUTION OF THE BOROUGH OF ELIZABETHTOWN DESIGNATING THE BOROUGH'S INTENT TO ERECT CROSS-STREET BANNERS BETWEEN TWO PPL POLES ACROSS MARKET STREET (STATE ROAD 230)

WHEREAS, the banners will be banded between two PPL poles (SCID:201—SCID:202) and suspended on cables across State Road 230 (Market Street) between Rita's Italian Ice and Lucky Ducks Bar & Grille at a minimum height of 17'6" above the highway; and

WHEREAS, the Borough of Elizabethtown assumes full responsibility for all liability for damages occurring to any persons or property arising from any act or omission associated with banners constructed and suspended in accordance with Borough banner regulations and the regulations of PPL and Penn Dot; and

WHEREAS, Elizabethtown Borough maintains an application and accompanying written procedures for requests to suspend a banner(s) submitted by an eligible entity which must be met for consideration of approval by Borough Council; and

WHEREAS, banners must only promote free local non-profit or cultural/civic events or activities; and

WHEREAS, no more than 20% of the space used to highlight the sponsor of the banner will be permitted; and

WHEREAS, traffic control will be performed in accordance with the most current Publication 213.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Borough Council of the Borough of Elizabethtown, Lancaster County, that Resolution 2017-1 designating the Borough's intent to erect banners across State Road 230 (Market Street) specifying conditions set by the Pennsylvania Department of Transportation, and permitting the organization listed below to suspend a banner under the following conditions is hereby approved:

Previously approved:

May 1—15, 2017 (Elizabethtown Arts in the Park)

November 27—December 11, 2017 (Elizabethtown Annual Holiday Parade)
