

# **Resolution No. 2018-10**

## **BOROUGH OF ELIZABETHTOWN LANCASTER COUNTY, PENNSYLVANIA**

### **A RESOLUTION OF THE BOROUGH OF ELIZABETHTOWN ESTABLISHING A TEMPORARY PARKING RESTRICTION ON THE NORTH AND SOUTH SIDE OF WEST WILLOW STREET AND EAST AND WEST SIDE OF NORTH POPLAR DUE TO THE CONSTRUCTION AND BRIDGE REPAIR THAT IS OCCURRING ON NORTH MARKET STREET.**

**WHEREAS**, Borough Council is granted the authority to create temporary parking restrictions while construction work is underway pursuant to Chapter 15 of the Code of Ordinances; and

**WHEREAS**, the construction and bridge repair on North Market Street has closed a portion of North Market Street and requires vehicular traffic to be detoured;

**WHEREAS**, the Chief of Police has analyzed the impact on existing streets and has recommended a temporary parking restriction on both the North and South side of West Willow Street and East and West side of North Poplar Street during the construction project;

**WHEREAS**, the Chief of Police has recommended the following a temporary parking restriction:

There shall be no parking on the North or South curb of West Willow Street, starting from the corner of West Willow Street and North Poplar Street and extending approximately forty-five feet from the corner (an extra fifteen feet beyond what is required by the PA Vehicles Code).

There shall be no parking on the East or West curb of North Poplar Street, starting from the corner of West Willow Street and North Poplar Street and extending approximately forty-five feet from the corner (an extra fifteen feet beyond what is required by the PA Vehicles Code).

This parking restriction will allow for an appropriate turning radius for any vehicle that is forced to turn onto West Willow Street as a detour around the location of the construction.

During the course of the temporary parking restriction, the Chief of Police may modify this restriction as dictated by the needs of Public Safety.

**WHEREAS**, the temporary parking restriction, on West Willow Street and North Poplar Street, is recommended to be in place retroactive to July 13, 2018 and remain in place until September 1, 2018.

**NOW, THEREFORE BE IT RESOLVED**, that the Borough Council of the Borough of Elizabethtown approves the temporary parking restriction on East Willow Street and North Poplar Street as recommended by the Chief of Police, and discussed at a regularly scheduled meeting of Borough Council.
