1. Approve or reject the Elizabethtown College, Preliminary Land Development Plan with the accompanying requested modifications and the following conditions:

Modifications:

- 1. SALDO Section 403.C.3 and 403.C.4 Locations of salient features within 200 feet of the subject tract
- 2. SALDO Section 607 Curb and Sidewalk

Conditions:

- 1. The modification of SALDO Section 607 shall only apply to the interior streets of the Elizabethtown College property and is not a modification of curbs and sidewalks on public streets.
- 2. A plan depicting pedestrian and bicycle ingress and egress to the Elizabethtown College property shall be provided to the Borough and will be submitted with subsequent Final Land Development Plans.

3. A sidewalk/pathway must be completed along Campus Road from College Avenue to the Elizabethtown College property line by December 31, 2022.
